**IMPORTANT CIRCULAR**

Subject: Mandatory Submission of Accurate Student Data for APAAR ID and ABC Portal

As per the guidelines of the National Education Policy (NEP) 2020, **all first semester students** are required to link their academic credits with their unique APAAR ID through the Academic Bank of Credits (ABC). This process is mandatory for every first semester student to ensure proper documentation of their academic journey.

In compliance with the instructions issued by Rajiv Gandhi University, all students are hereby directed to:

1. Ensure that the following details are identical across all official documents such as Class 10th and 12th Certificates, APAAR ID, AADHAR, PAN, etc. (Name of the student, Date of Birth and gender)
2. In case of any discrepancy or mismatch, students must update their records within 30 days of admission.
3. The student who did not attain their age 18 years they must contact the ABC Co-ordinator with their proper documents.
4. All students must fill out the Google Form provided below with their verified and correct data latest by 26<sup>th</sup> Sept 2025. Google Form Link: <https://forms.gle/Z8Svq4Gc1Rxy6n62A> or Scan this QR code:



**Important:** Failure to submit correct data within the stipulated time will result in:

- Disqualification from appearing in the 1st semester examination
- Rejection of data by the Academic Bank of Credits (ABC) portal, Ministry of Education, Government of India.

**CIRCULAR**

**Mandatory Compliance Regarding APAAR ID Data Matching.**

As per the guidelines of the National Education Policy (NEP) 2020, the generation and integration of the **Academic Bank of Credit (ABC)** and **APAAR ID** is mandatory for all students. These initiatives play a vital role in documenting each student's academic journey and ensuring flexibility in education by mapping all earned credits to their unique APAAR ID.

Rajiv Gandhi University (RGU) has been making continuous efforts to streamline the process of uploading student data to the ABC portal for both RGU and its affiliated colleges. However, several cases of data mismatches—particularly in documents such as the Class 10th and 12th Certificates, APAAR ID Card, AADHAR Card, PAN Card, etc.—have hindered successful uploads to the ABC portal.

**In light of the above, following instructions are hereby issued:**

All Heads of Departments of RGU and Principals of affiliated colleges should ensure that student details are identical across all mandatory documents and match exactly with those on the APAAR ID Card: Name of the Student, Date of Birth, Gender. In case of any discrepancy or mismatch in the above-mentioned details, students must update their data within 30 days of admission.

**Failure to update data within the specified timeframe the student will not be allowed to appear 1st semester examination, as their data will not be accepted by the Academic Bank of Credits (ABC) portal of the Ministry of Education, Government of India.**

**NB: Instructions for ABC Coordinators:**

All ABC Coordinators of RGU departments and affiliated colleges are instructed to verify student data during the admission process. Upon completion of admissions, the verified data must be compiled in the prescribed XLS format Google link (<https://docs.google.com/spreadsheets/d/1O33T8BgPW-pmQhJBmtRvTZotacFEMFW/edit?usp=sharing&ouid=116680953332540816413&rtpof=true&sd=true>) and promptly sent to the Nodal Officer at nad@rgu.ac.in. Timely cooperation is essential for ensuring the accuracy of student records and the effective implementation of NEP 2020.
